## **REGULATION AMENDMENTS**

**to open competition**

**“Delivery and Installation of Lift Fork”**

**Procurement identification No. LNO 2014/69**

Rīga, 2014

The Procurement Commission in 15/08/2014 meeting decided to amend an open competition “Delivery and Installation of Lift Fork” identification No. LNO 2014/69 regulation (hereinafter referred to as regulation) as follows:

1. Change clause 23.4. of regulation

References shall include the following information:               <ul style="list-style-type: none"> <li>- year when a similar service was provided;</li> <li>- contract price for provision of similar service;</li> <li>- positive assessment of recipient of service for the quality of service;</li> <li>- contact information of recipient of service.</li> </ul> </li> </ul>

to new redaction:

23.4.	The applicant (or manufacturer/ or authorized representative of manufacturer with right of delegation) during the last 5 years, has performed successful manufacturing and delivery projects of similar equipment.	<ul style="list-style-type: none"> <li>• To attest conformity to this qualification requirement the applicant shall submit compulsory at least 3 references from other contracting parties about manufacturing and delivery project of similar equipment.</li> </ul> <p>References shall include the following information:</p> <ul style="list-style-type: none"> <li>- name, registration number of the company which has performed manufacturing and delivery project of similar equipment;</li> <li>- year when the project was performed;</li> <li>- positive assessment of recipient of service for the quality of service;</li> <li>- contact information of recipient of service.</li> </ul>

2. Change clause 26. of regulation to new redaction:

“26. The association of suppliers may attest its conformity to requirements referred to in subclause 23.4 by submitting the references regarding the performance of the projects specified in subclause 23.4 which are performed by at least of one participant of association (or its represented manufacturer/ or authorized representative of manufacturer with right of delegation). Together 3 references must be submitted.”

3. Change clause 30.1 of regulation to new redaction:

„30.1. as to the qualification requirements referred to in subclause 23.4, the applicant may submit references for performances of projects specified in subclause 23.4 which are provided by the applicant itself (or its represented manufacturer/ or authorized representative of manufacturer with right of delegation) or by its subcontractor (or its represented manufacturer/ or authorized representative of manufacturer with right of delegation). Together 3 references must be submitted.”

4. Extend the tender submission term till 13 October 2014 12 a.m. Change terms referred to in clause 21. and 39.1. of regulation from „15 September 2014 12 a.m.” to „13 October 2014 12 a.m.”.
5. Extend the term of providing the service to 10 calendar months. Change terms referred to in clause 19., annex1 part II clause 7, annex 3 part I subpart II clause 3, annex 5 clause 2.2. from “8” to “10”.
6. Shorten the term of advance payment referred to in annex 5 subclause 5.2.1. from „within 15 (fifteen) working days” to within “5 (five) working days”.
7. Extend the term of the inspection of the object referred to in clause 14 of regulation, changing it from „from 5 – 18 August 2014” to „from 5 – 22 August 2014”.
